**Membership in Executive Women of the Palm Beaches is open to individuals of good moral character who live and/or work in Palm Beach County and meet certain professional criteria.**

**COMPLETED APPLICATIONS ARE REVIEWED MONTHLY.** You will be notified of your approval by letter. Upon approval of your membership, you will be asked to pay a membership and initiation fee along with submitting a photograph and biographical information for the directory. Dues are usually due and payable within 30-days from notification. **Your membership is active upon receipt of your payment and information.**

### **Membership Requirements**

#### **A. Regular Membership: Qualifying Requirements**

1. Regular (voting) Membership is open to individuals of good moral character who live and/or work in Palm Beach County and who meet the following criteria:
  - a. Is currently a member in good standing of a recognized profession and has been a member of such profession for the two years immediately prior to application for membership, or
  - b. Currently, and for the two years prior to application, has had a significant ownership position in a business, or
  - c. Currently, and for the two years immediately prior to application, holds an executive-level position or positions with a high level of authority and responsibility in one or more volunteer, public or private sector organization or organizations, or
  - d. Currently holds an elected public office;
  - e. And, in addition to a, b, c or d, above

Has demonstrated commitment to community service through documented volunteer service to a community-based public service organization or program, non-work related, through an active role of leadership, collaborative effort, individual achievement and/or special projects,

2. Sponsorship by a Regular Member in good standing who is familiar with applicant and her qualifications for membership. Sponsor shall be responsible for introducing applicant to the membership and for monitoring applicant during her initial year as a Regular Member.
3. Applicants for Regular Membership must attend at least one EWPB event within the two-year period immediately prior to making application.
4. Recommendation for Regular Membership by the Membership committee and an affirmative vote by the majority of the Board is required for approval for membership.
