



THE WOMEN IN LEADERSHIP AWARDS Call for Nominations - 2019

36th Annual WOMEN IN LEADERSHIP AWARDS to be Presented on April 17, 2019

The Executive Women of the Palm Beaches annually present the Women In Leadership Awards (WILA) to women of excellence in the Volunteer, Private, Public and Nonprofit sectors in Palm Beach County. The WILA Awards recognize women with outstanding credentials and accomplishments that display generosity of spirit, a commitment to integrity and diversity, and a genuine connectedness with others.

One Award will be presented in each of the following four categories:

1. **Nonprofit Sector:** A woman in a leadership role who works for a nonprofit organization and has demonstrated excellence in her career or profession.
2. **Private Sector:** A woman in a leadership role who works for a for-profit business organization and has demonstrated excellence in her career or profession.
3. **Public Sector:** A woman in a leadership role who works for a municipal, county, state or federal government agency and has demonstrated excellence in her career or profession.
4. **Volunteer Sector:** A woman in a leadership role who volunteers her time to make and has made a significant difference in Palm Beach County.

Criteria Candidates Must Meet for Consideration:

1. Nominee must have lived or worked in Palm Beach County for the last five consecutive years.
2. Nominee cannot be a current officer or board member of Executive Women of the Palm Beaches Foundation.
3. Nominee must demonstrate excellence in the sector she is being nominated.
4. Nominee must have made a demonstrated difference in Palm Beach County.
5. Nominee must show a history of commitment through a leadership position or positions in her respective Award sector.
6. **Nominee must be available to attend the WILA Panel Event scheduled for March 14, 2019 and the WILA Award Event scheduled for April 17, 2019**

Procedure for Nominating a Palm Beach County Woman of Excellence for a WILA Award:

1. Complete and submit the NOMINATION FORM. *Incomplete nomination forms will not be considered.*
2. Submit a one to two-page typed, double-spaced narrative describing specific examples that support the nomination. (Please see the suggestions on the third page of this packet as prompts for your response).
3. Submit a one paragraph summary describing the Nominee for purposes of publication. (Max: 100 words)
4. Submit a resume, curriculum vitae or work history of the Nominee.
5. Provide one COLOR DIGITAL PHOTO of Nominee in jpeg format, at least 4" x 6" and 300 dpi.
